Padmavati Bin Ullappareddy, R/o Chilakarappalli Village, Submitted application on 31/03/2006 for Mutation of the land of 3-00 Acre out 5.38 Acre of S.No. 21/1, being in Kasaba Hobli Singanaykanadinne Village, Bagapalli Taluk - in order to establish Old age House (Vruddhashrma) and Sharada Peetha. The applicants paid the required fees of Rs. 65467/- through Challan No.19 dated 7/6/2006.

The applicant's appeal has been verified in accordance with section 95 of Karnataka Land Revenue Act, 1964 and the provisions read under Karnataka Municipal Act/ Corporation Act/ Panchyat Act and Karnataka Country Town Planning Act. The Single Window Committee confirmed, after the necessary documents produced by them are got verified, that the applicants have fulfilled all the necessary conditions with regard to the related legal provisions and that the conditions in the regulations of the above mentioned Acts have been fulfilled.

The applicants have also submitted the Layout Plan approved by the competent authority. The Singal Window Committee has satisfied about that the applicants have followed the necessary procedures. Therefore, the Mutation has been given to Smt. B. Padmavati Bin Ullappareddy R/o Chilakarappalli Village, for the land of 3-00 Acres out 5.38 Acres land of

- 4. The distance from the middle of the roads regarding to National, State and District Highways prescribed by PWD Department should be preserved accordingly by the building proposed to be built in the land.
- 5. The road towards the Layout should be made in accordance with the Approved Layout Plan.
- 6. The inner Roads in the Layout should be made only in accordance with the Approval of Component authority in Single Window Committee
- 7. In accordance with the Design Plan approved by the Town Planning Department, the land should be utilized for the following purposes:-
 - 1) Park 1220.00 Sq.m.
- 2) Vehicle Parking 610.00 Sq.m.
- 3) Road margin 1275 Sq.m. 4) For Vruddhashrma & Sharada Peetha 8887.20 Sq.m.
- 8. If any of the above-mentioned Conditions are violated, this mutation order will be cancelled without giving any notice and further actions will be taken to lay penalty u/s 96 of Karnataka Land Revenue Act. 1964 The actions will be taken to collapse the unauthorized building built in the land without giving any compensation and the expenditure incurred for it should be collected from the property holder as the Arrears of Land Revenue.
