- 3) The earnings gained should be submitted to 'Shri Shri Shrungeri Sharadamba Devi Seva Trust'.
- 4) The 50% of the earnings gained after establishing the above mentioned Trust should be utilized to the developmental programs and functions of Religion, Culture, Education and Social Development.
- 5) Providing opportunity to Brahmins to learn Veda and Purana. Maintaining orphanage.
- 6) Establishing and Maintaining Schools and Colleges in forthcoming days.
- 7) Receiving any contribution from donors for the development of the Trust.
- 8) The donors have rights only to give advice for the sake of the development of the Trust.
- 9) By the difference of opinions, if there is impossibility for maintaining the Trust, then the overall assets of the Trust should be concerned unconditionally to 'Shri Shri Shrungeri Sharadamba Devi Seva Trust'
- 10) If the membership of the member of the Trust is vacated , then it should be filled by any person of the same caste. If any member resides outside the above mentioned address, then the member's membership should be cancelled.

- 11) The members of the Trust should elect the Executive Committee in order to execute the routine activities of the Trust. The elected Executive Committee should be convened at least once in a month and should execute the proceedings. General Body Meeting should be convened once in a year and the emergency meeting may be convened if it is required.
- 12) There should be a President, two secretaries, three treasurers in the Executive Committee and there should be five Executive Committees.
- 13) The board of the trustees shall cause true and correct accounts to be kept of the sums of the money receive and expended on behalf of the Trust and the audited accounts of the Trust shall be submitted in the Annual General Body Meeting every year. accounts audited by the auditors so nominated by the board annually. The journals and other books should be kept.
- 14) The amount of contributions received by the public should be preserved as Permanent capital.
- 15) Opening and maintaining accounts should be made with Canara Bank of Sajayanagar Branch in Bangalore. The operations of the bank accounts should be done jointly by the President and the Treasurer. The specimen signatures of the president and the Treasurer should be submitted to the Bank Manager.
- 16) The Trustees should frame the bye-laws, subsidiary rules and regulations required to the smooth execution of the activities of the trust with the accepted consent of all the members of the Trust.
- 17) The remaining fund of the trust after incurring for the activities of the trust should also be utilized for the other activities of the trust only after the agreed opinions of the members of the trust. **IN WITNESS WHEREOF** the settler trustee has signed to this deed of Trust.
